# Advances

- Presentation of progress on the SDGs before the High Level Political Forum on Sustainable Development.
- Installation of the Specialized Technical Committee on Sustainable Development (Presidency of the Republic-INEGI)
- The legislative branch installed the Working Group on the 2030 Agenda, which will provide follow-up on compliance with the SDGs.
- Installation of the National Council of the 2030 Agenda for Sustainable Development. • The Expenditures Budget of the Federation 2018 incorporates a sustainable development scheme for compliance with the SDGs.

# México

- This document aims to identify at first the institutional and administrative strengths and weaknesses, according to the type of municipality for a second, at the right time, the appropriate strategies for the development of the actions and the update in those, municipalities above the state average and define strategies to build capacities at the municipal level

# Background

- Designing a close and modern government to impulse de Agenda 2030 implies designing public policies based on the coordinated work between the government orders.
- According to the National Survey on Municipal Institutional Development, prepared by INDESOL-INEGI in 2015, it identified the following findings:
  - 86% of Mexican municipalities do not have basic internal administrative regulations.
  - 80% do not have a planning regulation

...

- 52% carry out public works without a specific regulation.
- 20% lack a development plan.
- 81% charges the property.
- 66% have updated their cadastral values.

These data reflect weakness and diversity in the national municipalities. Hence the relevance for the Government to strengthen its municipalities with differentiated strategies.

- In a descriptive and non-restrictive manner, the following strategies are presented to consolidate the administrative and institutional municipalities:
  - Organizational structures
  - Management systems in financial areas
  - Human capital Program Development System design
