A 1ª edição do Boletim Eletrônico de Bibliografias Especializadas traz publicações com o tema **Burocracia**. As obras fazem parte do acervo da Biblioteca Graciliano Ramos, da Escola Nacional de Administração Pública (ENAP). A literatura trata, por um lado, os aspectos da burocracia enquanto modelo de funcionamento do Estado.
